3. The learned Additional Public Prosecutor on instruction submitted that in Crime No.12 of 2016, charge sheet has already been filed and that the final report is yet to be taken on file.

4. Considering the fact that the investigation has already been completed by the third respondent in this case, this court is unable to entertain this petition for transfer of Crime No.12 of 2016. Hence this Criminal Original Petition is closed. However, the third respondent is directed to see that the charge sheet is taken on file within a period of four weeks from the date of receipt of a copy of this order.
