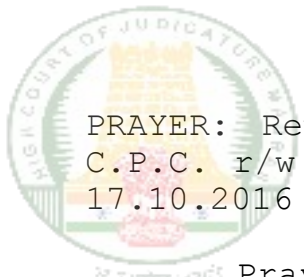

M.Alfred and others), the Commercial Taxes and Registration Department has also issued G.O.Ms.No.174, dated 28.11.2017, by amending the rule and prescribing time limit for making a reference under Section 47-A of the Indian Stamp Act.

2. In the light of the said development, nothing survives for further adjudication in this review application and hence, it is closed. No costs. Consequently, connected miscellaneous petition is also closed.
