4. When the matter was taken up for hearing, the learned Government Advocate submitted that civil suits are pending between the parties. It is further submitted that on the complaint given by one Innocent Rakini, sister-in-law of the petitioner, a petition enquiry was conducted and both parties have been advised to settle their disputes through the civil Court.

5. Recording the said submission, this petition is closed with a direction to the respondent police not to interfere in the civil dispute between the parties unless, there is a commission of cognizable offences.
