3.Considering the status report filed by the prosecution and also the report submitted for first extension by the Court concerned, for disposal of the case in Special Case No.5 of 2015, six months further time is granted from the date of receipt of the order copy by the learned Chief Judicial Magistrate, Kanyakumari District at Nagercoil. He is also directed to report the same to the Registry.
