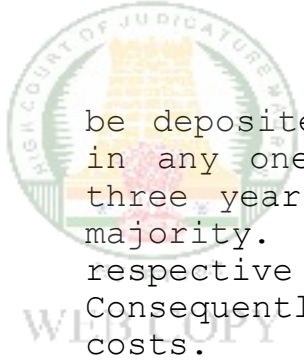

Prayer in WP(MD). 10277/ 2013 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus, to direct the respondents 1 & 2 to apportion 3/4th of the money standing in the credit of the petitioners husband Late Jeyapandi in Social Service Benefit Scheme and direct the Respondent Bank to give it to the petitioner and deposit the 1/2 share money of the minors in Fixed Deposit till they attain majority and to pay the Petitioner of her share and interest of Minors.
