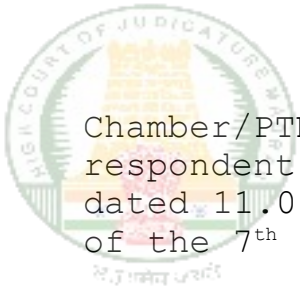

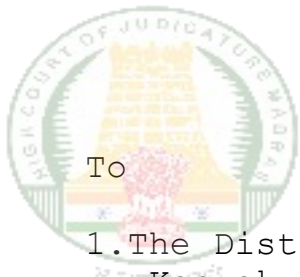
5. Recording the same, this Criminal Original Petition is closed.
