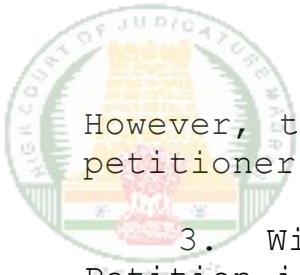

Now there is a dispute between the petitioner and Muthukalai, third respondent with regard to certain properties and a suit in O.S.No.176 of 2017 was filed by Balammal, W/o Muthukalai before the District Munsif Court, Dindigul and it is pending.

2. In view of the above, no direction can be granted by this Court to provide police protection to the properties in dispute.
