On instructions, learned Government Advocate (Crl.Side) submitted that on the complaint given by the petitioner, both the petitioner and the 3rd respondent were called for enquiry and during enquiry, it was



found that the dispute was essentially civil in nature and therefore, the same was closed on 17.04.2017 by advising the parties to work out their remedy before the Civil Court.
