The learned Counsel for the Petitioner submits that the petitioner has been implicated in this case for the alleged offences under Sections 7 and 8 of Protection of Children From Sexual Offence Act, 2012 and 3 (i), (xi), (xii) of the Scheduled Castes and Scheduled Tribes [Prevention of Atrocities] Act and that in view of the specific bar under Section 18 of the SC/ST Act, he cannot move any anticipatory bail application and



therefore, the petitioner has come forward with the above said prayer.

3. The learned Government Advocate (Criminal Side) takes notice for the respondents.
