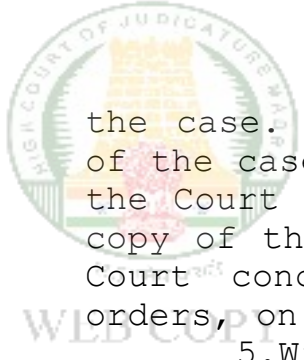
This petition is filed, for direction to the learned II Additional District & Sessions Judge (PCR Court), Thanjavur, to accept the surrender of the petitioner and consider his bail application on the same day on merits in relating to P.R.C.No.2 of 2016, on the file of the Judicial Magistrate No.III, Thanjavur.

2. The learned Counsel for the Petitioner submits that the petitioner has been implicated in this case for the alleged offences under Sections 294(b) and 506(ii) I.P.C., and Sections 3(1)(10), 3(1)(11) and 3(1)(15) of the Schedule Castes and the Schedule Tribes [Prevention of Atrocities] Act and Section 2(a) of Women Harassment Act, and that in view of the specific bar under Section 18 of the SC/ST Act, he cannot move any anticipatory bail application and therefore, the petitioner has come forward with the above said prayer.

3. The learned Government Advocate (Criminal Side) takes notice for the second respondent.
