ORDER

This Criminal Original Petition has been filed under Section 482 of the Code of Criminal Procedure, 1973, praying to call for the records in Crime No.281 of 2016 pending on the file of the first respondent and quash the same.

2.Heard the learned counsel appearing for the petitioner, the learned Government Advocate (Criminal Side) appearing for the first respondent and the learned counsel appearing for the second respondent and perused the materials available on record.

3.Based on the complaint given by the second respondent/de-facto complainant, the First Information Report has been registered against the petitioner in Crime No.281 of 2016 for the offences under Sections 147, 341, 294(b), 506(i) and 364 IPC. Challenging the said F.I.R, the petitioner has come before this Court.

4.Pending disposal of the above matter, both the second respondent as well as the petitioner compromised the matter and



filed a memo of compromise duly signed by the parties.

5.The second respondent is present before this Court and submitted that the matter has been settled between them. In view of the compromise memo filed by the parties, this Court is of the opinion that no useful purpose would be achieved by further proceeding in the matter.

6.In view of that, the impugned proceedings in Crime No.281 of 2016 on the file of the first respondent is quashed **and the petitioner is set at liberty and the Superintendent of Prison, Central Prison, Trichy is directed to release the petitioner on receipt of the copy of this order** and this Criminal Original Petition is allowed.
