2. The petitioners herein have obtained relief of anticipatory bail before the Principal Sessions Court, Virudhunagar. But they did not produce sureties within the time stipulated and they have filed Cr.M.P.1362 of 2017 before the Vacation Court for extension of time. The Vacation Court refused to take the said petition on file.

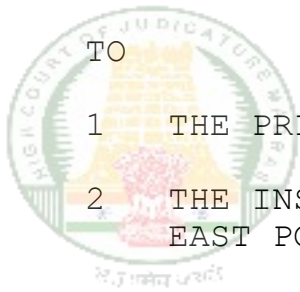
