These petitions have been filed to issue a Writ of Mandamus, directing the respondents to consider the candidature of



the petitioner in both the Writ Petitions for appointment to the post of Road Inspector Grade 2 in the light of the Government Order in G.O.Ms.No.34, Highways (HK3) Department, dated 29.01.2008.

2. One Thiru.Sheik Mansoor, petitioner in W.P.(MD)No.11185 of 2014, was aged about 37 years and the other one Thiru.Thuraf Mydeen, petitioner in W.P.(MD)No.11186 of 2014, who was also aged about 36 years old at the time of filing these Writ Petitions in the year 2014 . In view of the same they crossed the age of getting any appointment, to any post as stated by the Government Pleader. Mere empanelment in the employment exchange would not give them any right for direct recruitment. Now all the appointments are made only through Tamil Nadu Public Service Commission. Employment Exchange is only an Agency and petitioners cannot seek appointment on this account.

3. Hence, these Writ Petitions are dismissed. No costs. Consequently, the connected Miscellaneous Petitions are closed.
