ORDER

The respondent police is directed to file the closure report before the Executive Magistrate, namely the Tahsildar, Alangulam, Tirunelveli District, within a period of two weeks from the date of receipt of a copy of this order. The Tahsildar, Alangulam, is further directed to take photo copies of the closure report and other documents and send the originals to the learned Judicial Magistrate, Alangulam, within a period of two weeks



thereafter. Liberty is given to the petitioner to approach the learned Judicial Magistrate, Alangulam, for filing protest application, within a period of two weeks from the date of receipt of the records from the Tahsildar, Alangulam.

4. The criminal original petition is closed with the above direction.
