4.The learned Government Advocate (Criminal side) on <https://hcservices.ecourtts.gov.in/hcservices> submitted that a case in O.S.No.178 of 2005 is pending between the parties and under such circumstances no protection can be given to the petitioner to manage the temple.



5. Recording the same, this Criminal Original Petition is closed. However, if any cognizable offence is committed against the petitioner, liberty is given to the petitioner to approach the police to take action in accordance with law.
