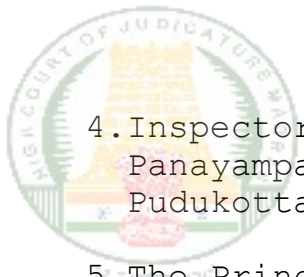
2. Heard the learned counsel for the Petitioner and the learned Government Advocate (Crl. side) appearing for the respondents 1 to 4.
