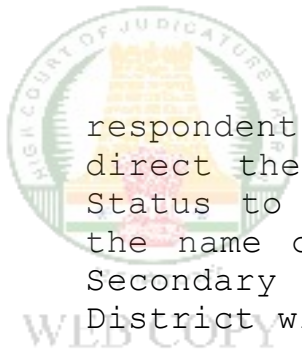

3.Recording the said letter, this writ petition is dismissed as withdrawn. No costs. Consequently, connected miscellaneous petitions are closed.

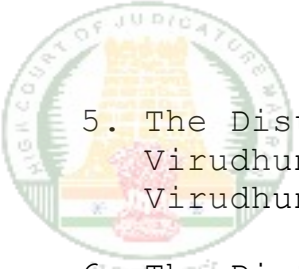
