ORDER

The petitioner is A-1 in C.C.No.239 of 2013 and he has filed the present quash application on the ground that he has arrived at a compromise with the *defacto* complainant.

2. In the considered opinion of this Court, in a trial where more than one accused are there, this Court cannot interfere and quash the prosecution as against one accused on the ground that he has entered into a compromise with the *defacto* complainant, as that will adversely affect the evidentiary value of witnesses before the Trial Court. That apart, the provisions of Section 34 of the Indian Penal Code will stand negated. Hence, this petition is dismissed. The Trial Court is directed to proceed with the trial in C.C.No.239 of 2013 expeditiously and complete the same, within six months from the date of receipt of a copy of this order, provided the accused co-operate with the trial by cross-examining the prosecution witnesses on the day they are examined



in chief, as held by the Supreme Court in **Vinod Kumar vs. State of Punjab** reported in **2015 (1) Scale 542.**
