Considering the limited scope of the prayer sought for in this writ petition, this Court, without going into the merits of the matter, directs the 1st respondent to consider the representation dated 26.06.2014 of the petitioner and after affording an opportunity of hearing to the petitioner, pass orders on merits and in accordance with law within a period of six weeks from the date of receipt of a copy of this order.
