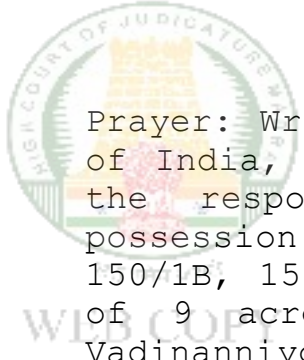

Crl.O.P.(MD) No.21647 of 2016 has been filed, seeking to direct the 2nd respondent to provide adequate Police protection to the petitioner and his family members and the petitioner has filed W.P.(MD) No.17360 of 2016, seeking to forbear the respondents in any manner disturbing the petitioner's possession and enjoyment of the land bearing Survey Nos.150/2B, 150/1B, 150/1A, 151/3, 153/2 and 154 in all totaling to an extent of 9 acres of Punja lands situated in Pidarenthal Village Vadinanniyoor Group Revenue village, Devakottai Taluk, Sivagangai District.

2. It is seen that there appears to be civil dispute between the petitioner and Ramanathapuram Samasthanam, Devasthanam Head Office, with regard to the property in question. Under such circumstances, the prayer in the writ petition as well as in the criminal original petition is not maintainable and it is for the parties to work out their remedies before the appropriate forum. Hence, these petitions are dismissed. Consequently, connected W.M.P.(MD) No.12588 of 2016 is closed. No costs.
