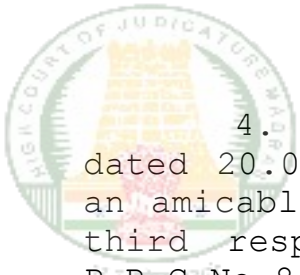

O R D E R

This petition has been filed by the petitioner seeking to quash the final report in P.R.C.No.8 of 2016 on the file of the learned Judicial Magistrate No.I, Sattur.

2. When the matter is taken up for hearing, the petitioner and the third respondent are present along with their counsel and their identifications were also verified by this Court, in addition to the confirmation of the identity of the parties by the learned Government Advocate (Crl.Side) through the respondent police.

3. Learned counsel appearing for the third respondent would submit that the matter is now compromised out of the court.



4. Further, both parties filed a joint compromise memo, dated 20.01.2017 stating that since the parties have arrived at an amicable settlement by way of compromise among themselves, the third respondent is not willing to proceed with the case in P.R.C.No.8 of 2016.
