Therefore, the petitioners are directed to surrender before the trial Court within a period of two weeks from the date of receipt of a copy of this order and on such surrender, the learned I-Additional District and Sessions Judge (PCR) Court cases, Thanjavur, is directed to consider the bail petition of the petitioners in connection with Crime No.218 of 2017, on merits and in accordance with law, after issuing notice to the de-facto complainant/victim, under Section 15 (A) of the SC/ST Act.

2. With the above observation this Criminal Original Petition is disposed of.
