O R D E R

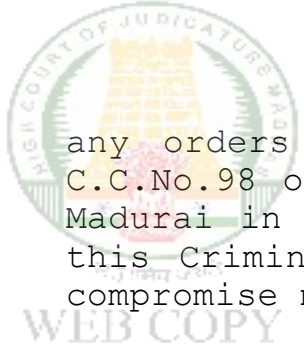
This Criminal Original Petition is filed seeking a direction, to call for the records relating to the case in C.C.No.98 of 2008 on the file of Learned Judicial Magistrate No.1, Madurai and quash the same.

2. It is seen that the alleged offences attributed against the petitioner is under Sections 406 and 420 of the Indian Penal Code.

3.When the matter is taken up for hearing, the petitioner and the second respondent appeared in person and their identification is also verified by this Court and the learned counsel appearing for the petitioner and the learned counsel appearing for the second respondent filed a memo of compromise stating that since the matter has been compromised, the second respondent agreed to quash the above said case in C.C.No.98 of 2008 on the file of Learned Judicial Magistrate No.1, Madurai.
