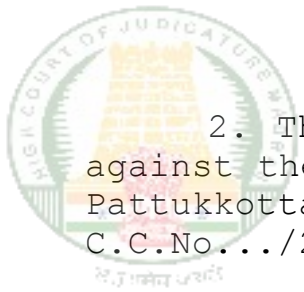

2. The revision petitioner herein filed a private complaint against the local police officials before the Judicial Magistrate, Pattukkottai in Crl.M.P.No.5794 of 2017 in Unnumbered C.C.No.../2017.

3. It is seen that the petitioner's family and the family of one Veeramani are at logger heads. Criminal cases have been registered at the instance of either parties against each other. The police officials are now sought to be made as victims in the fight between these two groups. The trial Magistrate rightly declined to take the private complaint on file.

4. I find no irregularity or infirmity in the order passed by the trial Magistrate in declining to take the petition on file. There is no merit in this Criminal Revision Case. Therefore, the present Criminal Revision Case is dismissed.
