The petitioners / A2, A3 and A4, who were arrested and remanded to judicial custody on 03.12.2016 for the offence punishable under Sections 304(ii) IPC r/w Sections 9A(1), 9(B)(1)(b) of Indian Explosive Act, 1884 and Sections 3, 4(b) & 5 of Explosive Substance Act, 1908 in Crime No.1 of 2016 on the file of the respondent Police, seek bail on the basis of the memo filed by the learned



counsel for the petitioner. This petition is posted today under the caption "for being mentioned", while the said petition is pending for orders.

2.Today the learned Senior Counsel for the petitioners and the learned Government Advocate (Crl.side) appearing for the respondent Police are present.

3.The learned Senior Counsel for the petitioners filed a memo, requesting this Court to permit him to withdraw this Criminal Original petition with liberty to file fresh statutory bail before the concerned Court. He also made an endorsement to that effect.

4.In view of the endorsement made, this Criminal Original petition is dismissed as withdrawn at present. Consequently, connected Crl.M.Ps.are closed.
