Prayer in CRP(MD)No.1658 of 2017:

Civil Revision Petition is filed under Article 227 of Constitution of India, praying this Hon'ble Court to allow this Civil Revision Petition and direct the Principal District Court(1st PDJ) Trichy to expedite and dispose the Execution petition in E.P.No. 616 of 2015 in O.S.No. 187 of 2012 on the file of the 1st Additional District Court, (1st PDJ) Trichy with in stipulated time.

This Court has already disposed of the Civil Revision Petition by order dated 11.10.2017, directing the trial Court to dispose of E.P.No.616 of 2015 in O.S.No.187 of 2012 together with E.A.Nos.53 and 54 of 2016, within a period of three months from the date of receipt of a copy of the order.
