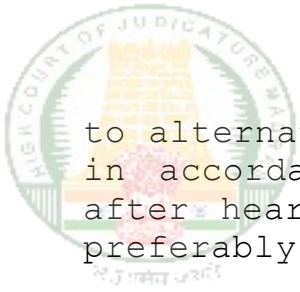

ORDER

Though the prayer in this writ petition is for issuance of a Writ of Mandamus, directing the Respondents 1 and 2 to realign the electricity power line to the home of Respondent No.3 to alternative way away from petitioner's home within a time frame, when the matter came up for hearing, learned counsel for the petitioner would submit that it is suffice, if a direction is issued to the respondents 1 and 2 to consider the representation of the petitioner dated 04.07.2015 seeking the abovesaid prayer, and to pass orders, within a time frame.

2.In view of the limited relief sought for, this Writ Petition is disposed of directing the respondents 1 and 2 to consider the representation of the petitioner dated 04.07.2015, seeking to realign the electricity power line to the home of Respondent No.3



to alternative way away from petitioner's home, and to pass orders in accordance with law, if there are no legal impediments and after hearing the 3rd respondent, within a period of one month preferably on or before 05.03.2017. No costs.
