Prayer in CMP(MD) . 3049/ 2018 IN CRP(MD)No.687/2018:-

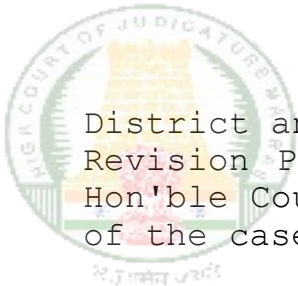
