PRAYER: Petition filed under Article 226 of the Constitution of India, to issue a Writ of Habeas Corpus, to direct the Respondents 1 and 2 to secure and produce the Petitioner's Son or his corpus by name J.Kannan, Son of V.Jeyaraman, Male, aged about 22 years permanently residing at Door No.6/48, Kalamman Kovil Street, Thirumal Natham, Rayapuram Post, Vadipatti Taluk, Madurai District who has been made illegal detention by the 3rd Respondent before this Hon'ble Court and subsequently set him at liberty forthwith.

The petitioner has filed this petition seeking production of his son before this Court and set him at liberty.

3.The learned counsel appearing for the petitioner submitted that detenu and his wife Indhu are presently living with the petitioner. He would further submit that since the marriage being inter-caste marriage there is threat from respondent No.3 and therefore sufficient protection may be given to the life and limb of the detenu and Indu.

4.Since we do not find any illegal detention, the Habeas Corpus Petition is closed with a direction to the second respondent to see that sufficient protection is given to the detenu and his wife.
