Today, when the Habeas Corpus Petition was taken up for consideration, the learned Additional Public Prosecutor for the respondents submitted that the detenu was arrested in connection with a criminal case in Cr.No.403 of 2017 under Sections 457 & 511 IPC, on the file of Rajapalayam South Police Station and produced before the concerned learned Judicial Magistrate and remanded to judicial custody.

3. In view of the above, since the detenu is not in illegal custody, nothing survives for adjudication in the Habeas Corpus Petition. Hence, the Habeas Corpus Petition is dismissed.
