Black Marketing and Maintenance of Supplies of Essential Commodities Act, 1980 (Central Act 7 of 1980).

Learned Additional Public Prosecutor reports that the order of detention passed against the detenu has been revoked by the Government by its order in G.O.Rt.No.72, Cooperation, Food and Consumer Protection (E3) Department, dated 30.03.2017, and he has also produced a copy of the Government Order.
