Mr.T.Mohan, learned Additional Public Prosecutor, on instructions from the respondents 1 and 2, would submit that the detenu was secured and she was produced before the learned Judicial Magistrate No.II, Thanjavur and the statement of the detenu was recorded and now she has joined her parents. Copies of the statement of the detenu have been produced by the learned Additional Public Prosecutor.
