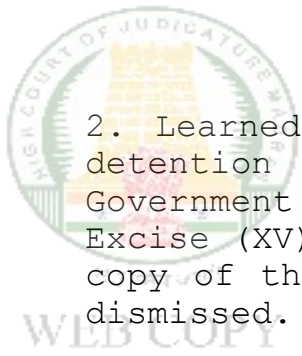
PRAYER: Petition filed under Article 226 of the Constitution of India, to issue a Writ of Habeas Corpus, Calling for the entire records in detention order passed in Cr.M.P.No.02/2017 dated 17.02.2017 on the file of the second respondent herein and set aside the same as illegal and direct the respondents to produce the body or person of the petitioner's husband namely Nagaraj, S/o. Kumarasamy, male, aged 42 years, who is detained in Central Prison, Tiruchirappalli before this Honble Court and set him at liberty.

The petitioner challenges the impugned order of detention, dated 17.02.2017 in Cr.M.P.No.02/2017, detaining her husband as "Boot Legger", as contemplated under the Tamil Nadu Prevention of dangerous activities of Boot leggers, Drug Offenders, Forest Offenders, Goondas, Immoral Traffic Offenders, Sand Offenders, Slum-grabbers and Video Pirates Act, 1982 (Tamil Nadu Act 14/1982).



2. Learned Additional Public Prosecutor reports that the order of detention passed against the detenu has been revoked by the Government by its order in G.O.Rt.No.1806, Home, Prohibition and Excise (XV) Department, dated 17.04.2017, and he has also produced a copy of the Government Order. Recording the same, the petition is dismissed.
