secured and she is being produced before the Juvenile Justice Board, Kulithalai, Karur District, on 07.04.2017.

4. In view of the said submission made by the learned Additional Public Prosecutor, we find that there is no illegal detention of the detenu. Therefore, the Habeas Corpus Petition is disposed of, giving liberty to the petitioner to approach the Juvenile Justice Board and meet her daughter, on 07.04.2017.
