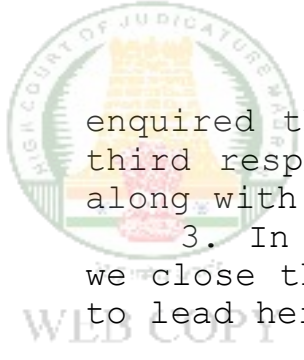
O R D E R

Seeking production of the detainee viz., Sindhuja, D/o.Late.Sudalaikannu, aged about 21 years, the petitioner, who is the aunt of the detainee, has filed the present Habeas Corpus Petition, stating that the detainee was found missing from 31.10.2016 onwards and since her whereabouts was not known, a complaint was made before the second respondent, based on which, a case was registered in Crime No.401 of 2016, as "woman missing". However, no effective steps were taken to trace out the detainee so far. Hence, the petitioner has come up with the present petition.

2. Today when the matter was taken up for consideration, the second respondent produced the detainee before this Court. When we



enquired the detenue, she told us that she fell in love with the third respondent herein and hence, on her own volition, she went along with him and both of them got married in a temple.

3. In view of the above said submission made by the detenue, we close the Habeas Corpus Petition leaving it open to the detenue to lead her own way of life.
