For R1 to R3 : Mr.T.Mohan

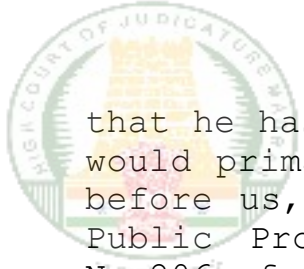
