2. The respondent - Police produced the detainee before this Court and when we questioned the detainee, in no uncertain terms she stated that she does not wish to join with the petitioner and she has not been kidnapped by the fourth respondent and she is leading a peaceful life by herself.

3. Thus, we find that it is not a case of illegal detention, but appears to be a matrimonial dispute. Therefore, we close the habeas corpus petition giving liberty to the petitioner to approach the appropriate Court for necessary relief.

4. Accordingly, this Habeas Corpus Petition is closed.
