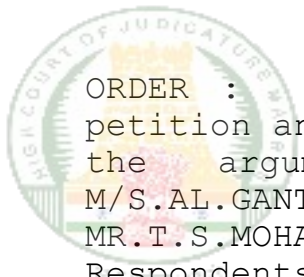

Prayer in WP(MD). 5271/ 2017 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue writ of mandamus or any order or direction in the nature or writ directing the 1st and 2nd respondents to take legal action against the 3rd respondent for the illegal encroachment of the porompokku land in S.F.No.541/2, 534/2, 535/1, 538/1, 539/1, 572/3, 542/2A and pathway going to the Kaliyaperumal Kovil in T.murungapatti village
