JUDGMENT

[Judgment of the Court was delivered by **G.R.SWAMINATHAN, J.**]

The Writ Appeal is directed against the order dated 06.07.2017 dismissing W.P.(MD)No.12527 of 2017 filed by the appellant herein.

2.The appellant is aggrieved by the appointment of the second respondent on 17.09.2012 as Noon Meal Assistant in Government High School, Valappakudi. The learned Judge held that the writ petition has been filed after the delay of more than five years. There is no explanation given by the appellant for the belated invocation of the court's jurisdiction.



3. In this case, the writ petitioner challenges the order issued in favour of the second respondent after a gap of several years. This writ petition was rightly dismissed. This writ appeal also stands dismissed. No costs.
