PRAYER: Writ Appeal is filed under Clause 15 of the Letter Patent Act, against the order dated 24.07.2017 made in W.P.(MD).No.13548 of 2017, on the file of this Court.

Prayer in WP(MD). 13548/ 2017 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Certiorarified mandamus calling for the records pertaining to the impugned proceedings issued by the third respondent in No.KA.NO.E.ME.PO/E&PARA/ 33/11/KIVO.THU.MI.KI/KUMBA/KO.THANI/A.N 0.15/2017 dated 15.05.2017 and quash the same and consequently direct the respondents to remove the illegal service connection / shifting bearing No.06-423-002-1445 installed in the petitioner property comprised in survey No.2264/3 and 2270/7 situated at Door No.64, Thangavilas Nagar, 6th ward, Srinagar Colony, kumbakonam, Thanjavur District.

**JUDGMENT**

[Judgment of the Court was delivered by **K.K.SASIDHARAN, J.**]

The Writ Petition filed by the petitioner was dismissed primarily on the ground that the proper party was not impleaded.

2. The learned counsel for the appellant, on instructions, submitted that the appellant would file a fresh Writ Petition, after impleading Mr.Sekar as a party. The learned counsel made an endorsement that he is withdrawing the Writ Petition. In view of the same, the Writ Petition is dismissed as withdrawn.

3. In view of the endorsement made by the learned counsel for the appellant that the appellant is withdrawing the Writ Petition with liberty to file a comprehensive Writ Petition, nothing survives for adjudication in this Writ Appeal.

4. The Writ Appeal is dismissed as infructuous. No costs. Consequently, connected Miscellaneous Petition is closed.
