In view of the submissions made by the learned Additional Government Pleader, the petitioner is directed to submit application for issuance of Community Certificate online furnishing the full particulars and the third respondent is directed to consider the petitioner's application, if it is complete in all respects, on merits and in accordance with law within a period of six weeks from the date of receipt of a copy of this order.

5. The writ petition is disposed of with the above directions. No costs.
