2. The learned counsel on either side would submit that the issue involved in this Writ Appeal is covered by the judgment of this Court in A.Solaimalai Vs. Tamil Nadu Public Service Commission, [W.A.(MD).No.5 of 2017, etc batch, dated 10.04.2017. Thus, following the said decision, the Writ Appeal is allowed and the order dated 07.10.2016 made in W.P.(MD).No.474 of 2016 is set aside and the the first respondent/TNPSC is directed to consider the grant of appointment to the appellant in the post of Typist, as per her ranking, subject to the appellant being qualified in other respects, within a period of twelve weeks from the date of receipt of a copy of this Judgment.
