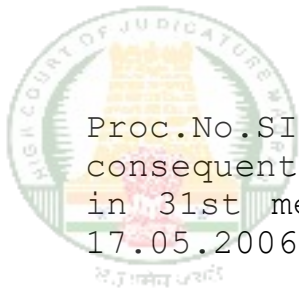

Proc.No.SIHM/ recovery dated 21.12.2012 quash the same and consequently direct the respondents to implement the orders passed in 31st meeting in Proc. No.SIHM/31st BOG/Restru.001/2006, dated 17.05.2006 with all monetary and service benefits.

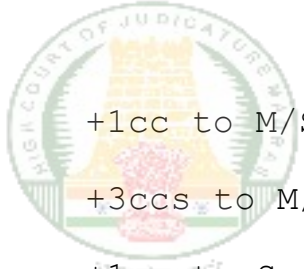
