Prayer in WMP(MD) No.10170 of 2017:

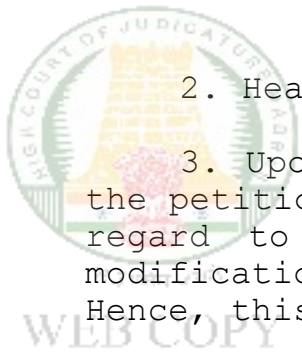
