quash the same as illegal.

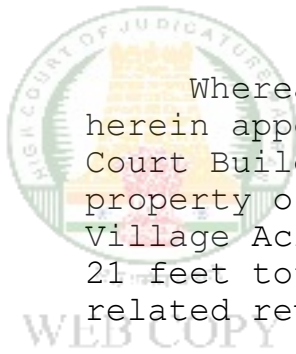
