The Writ Miscellaneous Petition is dismissed for non-prosecution".

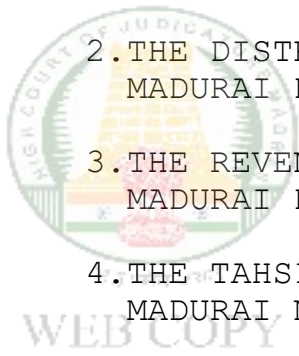
