Hence, the petitioner is not in prison and the detention period has also expired. Hence, the Criminal Revision case has become infructuous.

4.Recording the above statement made by the learned Additional Public Prosecutor, this Criminal Revision case is dismissed as infructuous. Consequently, connected CrI.M.P(MD).12735 of 2016 is closed.
