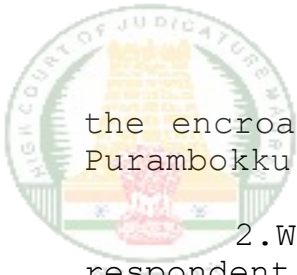

2. We direct the Tahsildar, Usilampatti Taluk, the second respondent herein to inspect the land in question in the presence of the petitioner and the fourth respondent. Notice shall be given to the fourth respondent at least one week before the date of inspection. The Tahsildar is directed to conduct a survey of the alleged encroachment in question and decide the representation submitted by the petitioner, dated 22.04.2014 on merits and as per law. Such exercise shall be completed within a period of three months from the date of receipt of a copy of this order.

4. The writ petition is disposed of with the above direction. No costs.
