The writ petitioner seeks a Writ of Mandamus, directing the respondents to take action to recover the land belonging to the State Boodhan Board and allot the same to the landless poor people.

2. The allottees, who are now in possession of the land, are not parties to the Writ Petition. It would not be possible to issue a Writ of Mandamus for recovery of the land without the association of those who are in possession of the land as on today. We, therefore, dismiss the Writ Petition with liberty to the petitioner to file a comprehensive Writ Petition after impleading all the necessary parties. No costs. Consequently, the connected miscellaneous petition is closed.
