PRAYER: Petition filed under Article 226 of the Constitution of India, to issue a Writ of Habeas Corpus to call for the entire records pertaining to the impugned detention order passed by the second respondent, made in his proceedings in P.D.No.38/2016, dated 15.10.2016, in detaining the detenu under Section 2(f) of the Tamilnadu Act 14 of 1982 as a GOONDA and quash the same and direct the respondents to produce the detenu, namely, Bharathidasan @ Bharathi, son of Soosairaj, Male, aged about 27 years, who is detained in Central Prison, Tiruchirapalli, before this Court and set him at liberty.

When the matter is taken up for hearing, Mr.C.Ramesh, learned Additional Public Prosecutor, submitted that the detention order, dated 15.10.2016, passed against the detenu, by name, Bharathidasan @ Bharathi, son of Soosairaj, aged about 27 years, has been revoked by the Government vide G.O.Rt.No.5955, Home, Prohibition & Excise (XV) Department, dated 25.11.2016, and he has



also produced a copy of the said Government Order.

2. In view of the same, nothing survives for adjudication in this Habeas Corpus Petition and it stands closed.
